OFFICIAL RULES

1. Sponsor

These Official Rules govern the Indeed Race to Austin Giveaway ("Giveaway") sponsored by Indeed, Inc. (the "**Sponsor**").

2. Eligibility

Open to legal residents of the United States, the United Kingdom, and Canada excluding Quebec, who are 18 years or older at entry.

 1. **Non-Indeed account holders:** You must create an account to receive one (1) entry. You may receive an additional entry by uploading, adding, or creating a new resume.
 2. **Indeed account holders:** You will be prompted to log in on the landing page. To receive one (1) entry, you must upload or create a new resume or update your existing resume.
2. Enter via the Alternate Method of Entry by mailing a 3"x 5" postcard: print your name, complete address, phone number and (if applicable) email address. The Sponsor will not accept and are not responsible for mailed entries that are late, lost, stolen, mutilated, damaged, incomplete, illegible, postage due, or misdirected.

Each eligible entrant may enter only once as outlined above. Only one (1) Indeed account per person is permitted. Use of multiple accounts or identities will result in disqualification.

One (1) potential ticket winner and two (2) potential second place prize winners will be selected by random draw. Appendix A – Travel Prize Terms

1. General

The travel stipend is intended to assist the winner with travel-related expenses incurred in connection with attending the event. The Sponsor will determine the method and timing of payment of the travel stipend. The winner is responsible for making all travel arrangements unless otherwise specified by the Sponsor.

2. Winner Responsibilities

The winner is solely responsible for:

- Obtaining and maintaining any required passports, visas, travel documents, or other authorizations.
- Arriving at scheduled transportation and event locations on time.
- Any expenses exceeding the amount of the travel stipend.

3. Expenses Not Included

Unless expressly stated otherwise, the prize does **not** include payment of or reimbursement of expenses, including but not limited to:

- Alcoholic beverages
- Ground transportation
- Parking
- Fuel
- Baggage fees
- Travel insurance

4. Travel Changes

The Sponsor is not responsible for:

- Flight delays or cancellations
- Hotel cancellations
- Event schedule changes
- Venue changes

- Weather
- Force Majeure
- Labor disputes

5. Event Cancellation

If the event is cancelled, postponed, relocated, or conducted without spectators, Sponsor reserves the right, in its sole discretion, to:

- substitute a prize of equal or greater value;
- reschedule the prize, if practicable; or
- award only those portions of the prize that remain available.

6. Failure to Attend

If the winner accepts the prize but elects not to attend the event, or is unable to attend for any reason other than the Sponsor's cancellation of the prize, any unused portion of the prize may be forfeited. If the travel stipend has not yet been paid, the Sponsor reserves the right not to issue the travel stipend.
